2. That council should have the **opportunity** to select the process of election of casual vacancies should they feel that election in a Union Meeting is not the most appropriate.

 - f) Council may, by means of passing an ordinary motion, resolve to elect unfilled posts by means of the procedure set out in Standing Order G for Web voting.
